COVID-19 and Telehealth

2020 has been a year of resiliency. We have adjusted our services to meet the needs of individuals in our community and we continue to implement new services to support our clients and staff.

Due to COVID-19, our Therapists, Psychiatric staff, and Case Managers are engaging in Telehealth services with our clients. Over 15,293 Telehealth sessions have been completed since the beginning of March 2020 in all four counties on the Treasure Coast, including 435 new intakes during this time. This was all possible thanks to the generous support of our grant donors: The Community Foundation Martin-St. Lucie, COVID-19 Rapid Response Fund, Impact 100 St. Lucie, and The Children's Services Council of St. Lucie. With their assistance, we were able to supply our staff with the technology necessary for Telehealth services, such as laptops, webcams, and printers/scanners. We believe every client deserves the access to care without involving the risk of COVID-19.



The Community Foundation Martin-St. Lucie awards Suncoast \$10,000 for Martin & St. Lucie County

Children's Services Council grants Suncoast \$5,000 for St. Lucie County Services Impact 100 St. Lucie awards Suncoast \$6,247.35 for St. Lucie County

Recognizing their efforts in the community, the COVID-19 Rapid Response Fund and The Community Foundation Martin- St. Lucie have awarded Suncoast with a grant in the amount of \$10,000. In addition to this generous act, Children's Services of St. Lucie County and Impact 100 St. Lucie have both awarded Suncoast with grants in the amount of \$5,000 and \$6,247.35. All of these funds were utilized for the purchase of 65 laptops, 4 printers/scanners, and 2 webcams for our staff to be able to work remotely offering Telehealth services. Over 15,293 Telehealth sessions have been completed since the beginning of March, including 435 new intakes during this time. This was all possible thanks to the generous support of our grant donors.

Suncoast awarded \$44,000 from Martin County and United Way of Martin County for mental health services





Due to COVID-19, Suncoast has seen an increased need for mental health services. Residents that have not reached out for mental health services previously are now seeking help due to anxiety, fear, and depression caused by the stress of this pandemic. This funding helped Suncoast protect the health of the community through funding individual therapy, group therapy, and case management services for adults in Martin County to encourage resilience during the COVID-19 pandemic. The funding was made available by Martin County Board of County Commissioners through the Coronavirus Aid, Relief, Economic Security (CARES) Act, and United Way of Martin County. This grant was active for 3 months from the beginning of October 2020 to December 30 2020.

Indian River Community Foundation grants Suncoast \$5,000 for Jumpstart Fundraising Program



Suncoast was awarded a grant of \$5,000 to participate in a year long program called Jumpstart Fundraising. This grant was a part of an initiative to help strengthen the operations of local charitable organizations serving in the Indian River County Community. The software Network For Good is being used with the purpose of organizing donor information, analyzing data trends, tracking incoming donations, managing tasks, creating marketing materials, and brainstorming with a professional fundraising coach. This software made a huge impact on the efficiency of our agency.

"I started coming to Suncoast Mental Health due to the fact that I have had a lot of life trauma, abuse mental and physically, neglect, and even had a baby by my rapist. We have been homeless for a short period of time and I've gone without eating or just without anything in general. As a mom of two, what was I gonna do? Well. I got help and the hardest thing I had to do was actually ask for help. Suncoast welcomed me and my oldest due to our past trauma. They were very welcoming and very willing to help us. There was a lot of change with them and at first it caused confusion on what I was going to do, but now they're in a bigger and nicer place. They have worked with me in so many ways. I'm truly grateful for this team and the help I got... I am no longer struggling with my drinking problem. I have forgiven my rapist. I still have stuff to work on but I look back to now and I'm the happiest I've been in my entire life. Who would have known I would be here writing thanking this place for truly caring and their staff going beyond their job just for me to get through these trying times. I am now married to the most wonderful man I could of asked for. He loves me while I'm learning to love me, the real me. Thank you for helping build a relationship with my mother to learning to cope due to my sisters passing and forgivingness. Again, thank you so much Suncoast Mental Health for never giving up on someone like me."
